Administrative Report

- DNR approved plans, specifications and bidding documents for the beach dock project.
- Beach dock construction project bids due 4-10-2018 with a substantial completion of September 28, 2018. The projected cost for the project is \$330,000 to \$350,000.
- Tax Cuts and Job Acts creates big incentives for Opportunity Zone Investments to delay paying tax on capital gains. Core of downtown Hancock and Houghton are included in the eligible districts.
- Houghton County building permits issued in 2017 were 52 new home and 316 total permits.
- UP Water and Sewers comparison is provided by the DEQ every 5 years. Hancock figures are competitive with others. There has been 22 million dollars of improvements to the water and sewer infrastructure since 2006.
- 2001 John Deere Grader is in poor condition and not work repairing. Currently using the back up grader for the 2nd half of winter. A new grader will need to be obtained before next winter. Bill Marlor will be looking into the options of purchase vs. lease. A new grader would be approximately \$225,000.

3/21/2018

- 1994 Chevrolet Diesel Dump truck has been decommissioned. This will need to be replaced in the next year. We use the dump trucks year round. A used 2004 is \$50,000 and a new one would be approximately \$120,000 to \$130,000. There is a garbage truck that can be traded in for a new truck.
- Michigan Treasury Department announced 110 of 490 local units of government are underfunded for retirement obligations. The City is not included in this list.

RESOLUTION # 18-05 OF THE CITY OF HANCOCK CITY COUNCIL TO WAIVE PENALTIES FOR THE LATE FILING OF PROPERTY TRANSFER AFFIDAVITS

WHEREAS MCL 211.7a(10) requires a buyer, grantee, or other transferee of property to notify the appropriate assessing office in the local unit of government where property is located of any transfer of property within 45 days of the transfer of ownership; and

WHEREAS MCL 211.27b provides for penalties if the buyer, grantee, or other transferee does not notify the appropriate assessing office in accordance with MCL 211,27a(10); and

WHEREAS MCL 211.27b(5) allows the governing body of the local tax collecting unit to waive by resolution the penalty levied under MCL211.27b(1)(c) or (d); and

WHEREAS The City of Hancock City Council desires to waive the aforesaid penalties;

NOW, THEREFORE, BE IT RESOLVED that The City of Hancock City Council hereby resolves in accordance with its rights under MCL 211.27b(5) to waive any and all penalties levied under MCL 211.27b(1)(c) or (d).

It being further resolved that The City of Hancock City Council does not waive its rights to levy and enforce penalties under MCL 211.27b(1)(a) and (b).
