Timothy Pinnow, President of Finlandia University gave a brief introduction of himself and his background in education. He spoke about his first 5 months on the job, his task of restricting the University to its new reality. He reviewed some of the cost saving measures they implemented, including trimming the budget by 12%, shrunk the employee base, mostly through attrition and no impact to full-time employees. They have too many buildings and land for their current student base of 400 and will be looking to sell those assets. The Finlandia Art Gallery has been closed as well. Looking forward they are working on education partnership ideas with the Copper Country ISD, Northern Michigan University and Marquette hospital.

Administrative Report

- Make A Difference Day is this Saturday from 9:00 am to 2:00 pm with help from local businesses like Superior National Bank, Finlandia University, OHM and many volunteers. This day very near and dear to Deb, so this year, in honor of her, you will see "You've been Debbed" signs around town encouraging people to do something that makes a positive difference, there are stickers with each sign to encourage others to do the same. Also, Deb Mann's family will have a celebration of life for her this Saturday as well from 11:00 am to 2:00 pm at Finlandia's Finnish American Heritage Center.
- City Manager Babcock gave an overview of the police millage which will give the City the ability to hire a full-time officer to alleviate the overtime. In previous years there has been as many as 8 part-time officers available to cover time off requests, at present, there are not any part-time officers available.

- A new tree will be planted behind the Hancock Sign in West Hancock. Superior Tree Farm has donated a Balsam Fir Tree in honor of Deb Mann, and have greatly discounted the placement costs with the DPW assisting them in placing the tree.
- RRC Certification event is scheduled for November 18th with State officials and representatives attending the event and community attendance is encouraged. A local business is already using the benefits of the certification to apply for a grant.
- Hancock Rotary is hosting fund raising Wine Tasting Event on November 4th at the Finlandia Finnish American Heritage Center from 7:00 pm to 9:00 pm. Proceeds go toward Hancock Rotary volunteer initiatives.
- Public Notice was posted on October 4th with Boards/Commission Openings for the Zoning Board of Appeals, Board of Review, Rental Code Board of Appeals and the Recreation Commission, hope to be able to appoint people at the next council meeting.
- Western U.P. Planning & Development region announced a grant opportunity through MSHDA MI-HOPE Program. Home owners can take part in the Increasing Home Energy Efficiency virtual event hosted by MSHDA Neighborhood Housing Initiatives Division on Wednesday, October 26 from 5:00 to 6:00 pm for home owners to see if they may qualify for the funding.
- Tami Sleeman has accepted the position as the new Hancock Police Chief. There was a committee of 5 people who were involved in the interview and selection process.
- Union negotiations will start next week, Teamsters is scheduled for 10/26, COAM for 10/27 and POAM for 11/1. If any council member is interested in being on the negotiations committee, let City Manager Mary Babcock know and she will forward the information.
- We have been using the garbage stickers for about 4 weeks; we are getting feedback both ways, some like them, others don't.
- Fire Chief, Bill Lepisto gave an update on the maintenance and repairs of the Pierce Aerial Truck. It is a 2000 model year and would normally be looking at replacing. He met with the Pierce Aerial engineer, after inspecting the truck, he said it was in excellent condition and would recommend refurbishing the truck at a cost of approximately \$250,000-\$300,000. It would cost between \$1.6 million and \$1.7 million to purchase a new replacement truck.
- Clerk/Treasurer, Linda Kalinec gave an update on the absentee voter ballots sent and received to date, 544 sent and 104 returned. Also, the audit is winding down, working with Munetrix on the CVTRS (Revenue Sharing) reporting that is due December 1 and the transit ridership is returning to pre-COVID numbers. The winter parking ban will go into effect on November 1 and Trick-or-Treating will be from 5:00 pm to 8:00 pm.
